X1 Enterprise Platform, powered by X1's proprietary¹ index-in-place technology, is the only data discovery solution in the industry that enables you to perform **lightning-fast, federated, and highly targeted, custodian-based search and collection of both on-premise and cloud-based data sources** including the full Microsoft 365 suite of Teams, OneDrive, SharePoint, Mail, as well as remote laptops, desktops and large network file-shares.

X1 has taken a completely unique and revolutionary direct approach to data discovery in M365 that industry analysts state **"even surpasses in many respects Microsoft's own Premium Purview services"**.²

In fact, unlike X1, Microsoft relies upon a technology approach that Special Master Phillip Favro, appointed by a federal district court for Deal Genius, LLC vs. O2Cool, LLC, 21 C20156, (N.D. IL), reported, **"Microsoft 365 has technological limitations that may not allow a responding party to generate reliable search results—as would typically be possible with an electronic discovery platform that has a fully indexed database and an advanced search engine"**.³

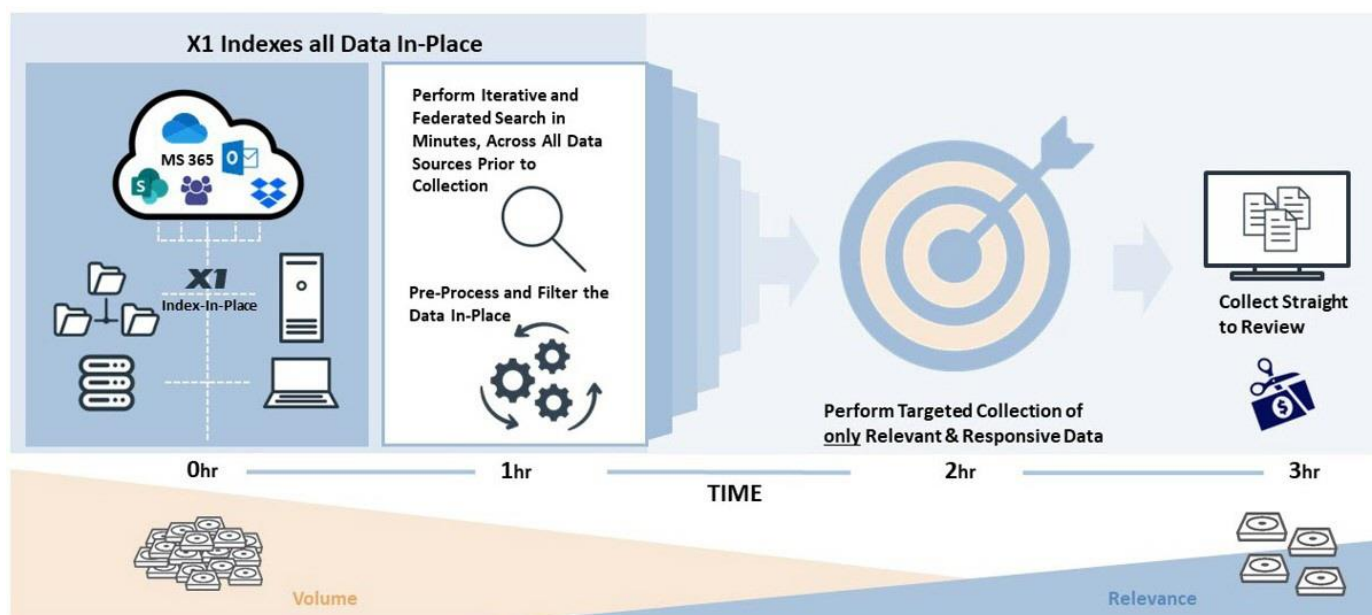

And while all other 3rd party solutions simply integrate their "cloud connectors" via Microsoft's own Search and eDiscovery API's, which result in the same if not greater limitations in the fidelity of their search results and the data throughput and throttling limitations of those APIs, X1 has taken a completely different and direct approach that leverages our own patented and purpose built for eDiscovery index-engine and index-data-in-place methodology. For example, X1 can address a matter involving 100 custodians at 10 GB of M365 data each within 24 hours (search, collection and export), while Microsoft Purview Premium or 3rd party solutions using their API's would take up to several weeks or months.

With X1's **direct integration, robust index-in-place capability, and advanced search and collection engine**, only X1 Enterprise Platform (X1EP) enables unified and federated search from a single technology interface to perform targeted collection and only collect what you need. X1's direct approach eliminates the need for premium licensing, reducing eDiscovery costs by 90% or more, and accelerates your data discovery process to get comprehensive and fully-defensible results into review in hours versus weeks or months.
